Soil Erosion – the application will install practices that address gully erosion. 15 pts

Soil Erosion – the application will install practices to reduce soil erosion to T or less. 10 pts

Water Quality – the application will address water quality concerns in priority watershed listed in question 3 above. 15 pts

Water Quality - the application will address water quality concerns outside of priority watersheds listed in question 3 above. 1pt

All Concerns – the application will install practice that addresses a national priority concern in Lincoln County. 1 pt

Soil Erosion and Water Quality – the application will install practices that implement a prescribed grazing system. 10 pts

All Concerns – the application is within a TMDL area. 5 pts.

6. **Submit this worksheet to your respective ASTC(FO). After approval from the state office, the questions will be entered into the Local Issues section of the ranking tool.**
